2021-22 School Safety Plan

The school Emergency Preparedness Plan includes procedures for emergencies such as fire, earthquakes, lockdowns, and intruder alerts. Other logistical items such as location of exit routes, and inventories of emergency supplies, are also included. The VRB Safety Plan is available in the school office, and is reviewed with all staff during one of our staff meetings. Our school participates in monthly drills that take place for fire, earthquake, and lockdowns. Emergency preparedness trainings for all staff members take place annually; as a district and school we will be implementing the ALICE strategies in case of an active shooter on campus.

With the return to in person instruction, we have also made adjustments to adhere to safety protocols for staff working on campus. Our campus has been closed to the general public since the beginning of the school year, parents needing any assistance will call the main office for support in setting up appointments to visit teachers, attend IEP meetings or to meet other departments as needed.

While on campus, staff is to:

- 1. Get temperature checked in the office breezeway;
- 2. Adhere to social distancing standards, wear masks, covering both nose, and mouth;
- 3. Encouraging students to wash their hands on a regular basis;
- 4. Maintain doors, windows open weather permitting, and utilizing classroom air purifiers provided by the district office.
